- Approved permit applications, plans and corresponding paperwork will be kept in our office for 90 days from the date of approval. You will be notified that your permit has been approved by telephone or e-mail. **In the event that the permit is not paid for or cancelled within that 90-day period, it will be destroyed. To resubmit, the contact will have to start the permit review process over again.**
- I hereby certify that I have read and examined this application and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not.
- I agree and understand that in the event the City of Bellaire or any franchised utility will need access to or the use of the right-of-way, the improvements that I might place upon said right-of-way may be removed, destroyed, or otherwise relocated, and that I waive any and all claim that I have in such eventuality
